### **ATTORNEYS RESPOND – THE HOTLINE**

To the business friends who've inquired or commented during the many virtual networking events, The Law Office of Debbie Weecks is privileged to continue to volunteer three days weekly as a hotline operator. Some data provided for the time period of May 20<sup>th</sup> through close of business this past Friday June 19<sup>th</sup>, from the notification to the volunteers from the Bar staff:

There are 112 of us who have collectively fielded 433 calls. The top legal issues are housing (27%), employment and unemployment (20%), and other legal questions (17%).

Like me, you probably see the stats and wonder why it's not a 100% tally. That's because the listing is the top issues about which we have fielded calls. Then we give the caller appropriate resources, such as information or forms or a referral for a half-hour courtesy call with an attorney one-on-one about the caller's case. The breakdown in the bulletin to us includes that collectively the hotline has provided 148 referrals to free consultations and we've helped 29 small business owners.

## **ANOTHER US SUPREME COURT CASE – DACA**

### Deferred Action for Childhood Arrivals

In the prior issue, the Law Office provided you the link to the important new case of the day from the United States Supreme Court regarding gay and transgender employment protections (*Bostock v. Clayton County*). Yet another landmark case followed last week. That case permits DACA recipients (“dreamers”) to maintain their current status for now. *Department of Homeland Security et alia v. Regents of the University of California et alia* (18-587, 18 June 2020) explored an injunction that was upheld against a previously proposed DACA expansion and another initiative known commonly as Deferred Action for Parents of Americans and Lawful Permanent Residents (DAPA).
